Minutes from the WPNA meeting: 1/14/17

- I. Welcome new neighbors, thank sponsors, donors, members, and newsletter deliverers: Meghan Dougherty (7 new visitors from the neighborhood, 1 sponsor of the newsletter was present, several newsletter deliverers present-thank you!)
- II. Review and approve minutes from November meeting: Emily Vitris

Charters Wynn made a motion to approve, it was seconded and there was no further discussion.

III. Update on Safety, meeting our new District Representative: SPO Chris Pittman, APD

Harold Ristow, covers IDA one and Chris Pittman covers IDA two. Harold can be reached at 974-5046. Chris can be reached at 974-5521. Berkman to West is IDA 2 and Berkman to East is IDA 1.

They serve as District Reps/community liaisons: dogs barking, speeding cars, etc. Not 911 type calls or regular patrol cars. They can put out the speed trailer if people are speeding. Officer Pittman discussed group homes in our neighborhood and the challenges of people who leave group homes, but continue to stay in our area. Cameron Road has a high number of transients.

IV. Improving the Walkability of our neighborhood: public works, sidewalks: John Eastman, Project Manager Street and Bridge Sidewalks and Special Projects Division Public Works Dept. City of Austin The city is missing about ½ of the sidewalks it is designed to have. It could cost around 1 billion dollars to complete that amount. Google "city sidewalk masterplan" to see where the city is going to prioritize the sidewalks construction in the city. Significant number of high priority areas in WP.

Priority sidewalks are mostly located on east/west streets north of Briarcliff and few south of that. Could this be reconsidered? What is the process to get changes made to the sidewalk plan?

The city's goal is to get a complete network of sidewalks. They tend to be focused on what is near to transit. Over 400 million dollars of high priority sidewalks listed. 10% of the priority needs are funded currently. Mr. Eastman said that if the neighborhood comes together and identifies high priorities, they are very open to that information and it could change the high priority plans for the neighborhood.

10 foot right-of-way was explained in further detail. Ten-day construction notices are provided if a sidewalk is going to be built on your street.

How do we go about requesting changes to the plan? Read the plan and narrative (section 4) for the sidewalk master plan. The sidewalks team is happy to help facilitate a workshop style meeting to discuss further the priorities of sidewalks in WP.

We need a new transportation committee chair. If you are interested in volunteering, please let Meghan know.

Sheryl called the question. It was seconded. 4 people abstained from the vote. The audit committee was appointed.

VII. Propose background check policy for officers: Dan Strub

Dan presented an amendment to the bylaws. The change in the bylaw was written by Dan Strub, explained, and presented to the membership.

Discussion occurred. There was discussion/concerns raised about the necessity of these checks and the invasion of privacy that such a check might entail.

Proposals/revisions to the bylaws were suggested.

Brian moved that the matter be tabled, it was seconded. Motion passed.
